Dear Friend of South Dakota Right to Life,

"The More Things Change...The More They Stay the Same."

That old adage is true ... sometimes.... somewhat.



And it came to mind as I considered what has changed, and what has not, one and a half years after the historic Dobbs v. Jackson decision of the U. S. Supreme Court.

<u>Dobbs was the decision that struck down the tragic Roe v. Wade ruling which had ushered in 49 years of unlimited abortion and the slaughter of over 63 million unborn baby girls and boys. Roe was the epitome of evil itself and it had to be reversed!</u>

Reversing Roe was a tremendous, hard-won victory for the pro-life movement and for everyone like you and me who care about life and have worked and prayed so hard to defend it.

That victory was achieved through decades of non-stop work in the halls of Congress, our state legislature, in the voting booth and in countless educational talks, events, and rallies across South Dakota and across the nation.

And the Dobbs decision did bring change! America was no longer stained by the wicked Roe mandate that had made killing innocent children a fundamental right. Such child sacrifice was no longer the "law of the land."

It is now up to us, acting through our elected representatives, at the ballot box and through our sphere of influence, to determine if unborn children will be protected - or not.

In many states like South Dakota it has already been possible to pass strong protections for unborn children, in others lesser protections have been passed, while in others pro-abortion legislators, governors or judges have blocked protective legislation or even sought to expand and promote their abortion business to women in other states!

Something else changed with the Dobbs decision as well. The pro-abortion forces of death roared back with a vengeance like never before. From the print, TV, and radio media to the entertainment industry and across the pro-abortion political landscape, the beast that is the abortion lobby fought back with

their lies and distortions.



They **falsely claimed** that any pro-life legislation would mean that women could not get the most basic maternal care needed. They claimed that the pro-life movement sought to punish women and "put them in jail". And they continued to deny what abortion really is.

And the abortion industry does have the big bucks to broadcast their lies about abortion and pro-life efforts. Remember, Planned Parenthood alone has an annual income of about one and one half BILLION dollars.

But despite the pro-abortion propaganda onslaught, there is already strong evidence that abortion numbers are being lowered and lives are being saved. We praise God for that. Sadly, there is also clear evidence that many, many babies are still dying.

So yes, many things have changed, and more lives are being saved. But many things have stayed the same.
