The Executive Director's Message

The time is now. Let YOUR VOICE be heard



As SDRTL focuses on our plans to move ahead in the battle to protect life in all stages from conception to natural death, the Word of God instructs us as to our attitudes and even our methods: "And walk in love, even as Christ hath loved us, and hath given himself for us, to be an offering and a sacrifice of a sweetsmelling savor to God." (Ephesians 5:2, 1599 Geneva Bible [GB]) "Take heed therefore that ye walk circumspectly, not as fools, but as wise, Redeeming the season: for the days are evil." (Eph 4:15-16 [GB])

Pro-life men have a God-given instinct to protect women and children from harm. Pro-life women have an innate impulse to care for and nourish children. Yet, the uninvolved majority of us go about our daily lives of school, church, work and play activities while women are injured and thousands of babies are quietly and lawfully murdered in the name of 'healthcare'. While we are enjoying the many gifts and freedoms God has granted to America, on our own watch millions of babies are being slaughtered by abortion.

God's Word commands us to use our time wisely. Spending our Pro-Life time and energy running off in a hundred different directions is nothing but motion without movement! Focus is important.

Therefore, SDRTL focuses on legislation and education to protect defenseless human life from abortion, infanticide, assisted suicide, euthanasia and related issues.

Clarke D. Forsythe, J.D., Senior Counsel at Americans United for Life (AUL) recently said, "One of the great, unheralded achievements of the cause for life in America has been keeping Roe unsettled over the 45 years since it was decided, despite ferocious hostility from powerful forces and cultural elites."

In responding to this statement, the RTL of Greater Cincinnati recently wrote the following: "In order to keep Roe 'unsettled', the pro-life movement must continue to drive PRO-LIFE LEGISLATION that challenges Roe v Wade, and we must elect PRO-LIFE LEGISLATORS and PRO-LIFE JUDGES who oppose it. This fight is not won with weapons and physical exertion. The fight for life will be won or lost in the courtrooms of the United States."

And it is on the state scene as well as the federal scene that the battle must be won. Here in South Dakota, we came out of a very successful Pro-Life Legislative session. We were gratified to have six pro-life bills signed into law and to have the passage of two stronglyworded, pro-life resolutions. Today our work seeks to continue strengthening the pro-life movement in South Dakota.

Our country is severely divided over the question of the value of life. If Roe v. Wade was overturned today, only ten states (including South Dakota) would have enforceable laws prohibiting abortion before twenty weeks, or viability. Eighteen states and the District of Columbia would have enforceable prohibitions only after twenty weeks. The remaining twenty-two states would

have abortion on demand throughout pregnancy.

Make no mistake. The 2020 election will be about ABORTION. And our political victory is far from certain. Some believe we may need a six-justice majority on the Supreme Court to overturn Roe v Wade. We must keep the Presidency and the Senate in 2020, and we must elect pro-life judges and legislators.

Pro-life men and women, the time is NOW! No longer can we afford to be PASSIVE – FORGETFUL – FEARFUL- SILENT. SPEAK UP AND LET YOUR VOICE BE HEARD!

Mark Twain says, "The two most important days in your life are the day you are born and the day you find out why." So, ask yourself WHY you were born and, more importantly, why you were chosen to live on this earth at this point in time. You are called to join this Pro-Life fight. There is a place for everyone, and we must leave no position unfilled.

And, so I ask – what will YOU do?



Where your Donations are Going

Our South Dakota Right to Life Board works diligently to make the most of every contribution we receive. Here is a breakdown of how your donations have been spent in 2019. Chapter and fair supplies take up nearly a quarter of our budget every year.

SDRTL offers support to roughly 40 chapters and participates in a wide range of fairs and events. Your donations ensure that we are always distributing new and innovative displays and pro-life materials. About 40% of our budget goes toward providing staff in supporting chapters, expanding pro-life outreach, and coordinating our booths at fairs and other events



along with another 7% of our budget on supplies and materials for chapters and fairs. Sending LifeFacts to 16,000 households four times a year is one of our biggest educational expenses, consisting of roughly 22% of our yearly budget.

Lobbying takes up about 13% of our budget. Each session we have a fulltime lobbyist in Pierre working with our legislative committee to develop, refine, and push through meaningful pro-life legislation that helps educate and save lives while blocking anti-life legislation in its tracks. The success of our lobbying efforts has been stunning: 27 pieces of pro-life legislation passed within the last nine sessions. Four percent of our budget is spent on maintaining an office and storage space in Rapid City.

Another 4% is used to send South Dakota delegates to National Right to Life meetings, conventions, and trainings and provide support to National Right to Life. Two percent of our budget is spent on paying for fair booths and expenses for other events to ensure our pro-life message is reaching people throughout the state. Only 2.3% of the budget is being spent on administration membership mailings, postage, and office supplies. Miscellaneous education expenses are less than 5% of our budget and include things like our essay contests, Hour of Reflection, convention, and other education opportunities.

Every dollar that you donate gets stretched to its breaking point and supports a large network of chapters and volunteers committed to furthering and cementing our gains toward a culture that values LIFE. Thanks so much for supporting your South Dakota Right to Life!

A Day of Fasting and Prayer

During the 2019 Legislative Session the SD House of Representatives adopted House Resolution 1003. SDRTL Board Member and Representative Jon Hansen was the Prime Sponsor of HR1003 which denounced the recent passage of New York's abortion law and requested that Governor Noem declare a day of prayer and fasting to atone for the unspeakable crime of abortion. The Governor agreed, and had declared May 4th as a statewide day of prayer and fasting for all. Even though the date of May 4th has come and gone may we be ever mindful to continue to PRAY for an end to abortion as her Proclamation and our Lord encourages us to do.

Executive Proclamation

State of South Dakota Office of the Governor

Whereas, On the forty-sixth anniversary to the day of the Roe v. Wade decision, the Honorable Andrew M. Cuomo, the fifty-sixth Governor of the state of New York, signed into law an act that permits nearly limitless abortion of a child in utero, even in the last moments before that child's eyes see the light beyond the womb; and,

Whereas, Other states in our Union may seek to follow this path. All life is sacred and that every person has dignity and worth. We are speaking of fully-formed babies. We are speaking of human beings with fully-formed hearts and lungs, eyes and mouths, hands and feet, utterly indistinguishable from our own children and grandchildren; and,

Whereas, Life is sacred from the moment of conception. We know, by the eternal law and the evidence of history, that the destruction of innocent life cries out to heaven for justice. With all humility and in fitting fear for perdition, it is thus proper to bow before the unseen Author of all life and beg mercy in atonement for our sins and the sins of our countrymen, that the cause of our sadness might be lifted from this land and harmony among all restored; and,



Now, Therefore, I, Kristi Noem, Governor of the state of South Dakota do hereby proclaim May 4, 2019, as

A DAY OF PRAYER AND FASTING FOR ALL

In South Dakota and I respectfully request people of all creeds or none at all to observe this day with solemn mourning and pleas to heaven as best their consciences do direct.

In Witness Whereof, I have hereunto set my hand and caused to be affixed the Great Seal of the state of South Dakota, in Pierre, the Capitol City, this First Day of April in the Year of Our Lord, Two Thousand and Nineteen.

South Dakota Right To Life Legislative Session Results

South Dakota Right to Life supports legislation that helps protect the right to life of all defenseless human beings from conception to natural death. Thus, I served as your SDRTL's Lobbyist during the 94th SD Legislative Session from January 8 to March 13, 2019. While we wait on federal Pro-Life legislation, our own SD Legislature did their Pro-Life best as they passed six Pro-Life Bills, which Governor Noem quickly signed into law, and two Pro-Life Resolutions. I found it amazingly reassuring to work side-by-side with two of our SDRTL Board Members who are currently serving in the SD Legislature: Representative Fred Deutsch (District 04) and Representative Jon Hansen (District 25).



These six Pro-Life Bills and two Pro-Life Resolutions are listed on PAGE 7 including their vote tallies. Although, all eight of these pieces of legislation passed with overwhelming Legislative support, each came with sometimes significant twists and turns in order to get them across the finish line.

Also, listed on this Legislative Chart is the one Bill SDRTL chose to oppose - SB6. Although we believe it's Prime Sponsor to have been well-intentioned with the bringing of this bill, none-the-less we found it to be poorly written and poorly timed. Thus we were left with no option but to oppose SB6 in Senate Committee. While we were grateful with the defeat of SB6 in the Senate Committee, we were even more appreciative that the Prime Sponsor of SB6 went on to Sponsor in the Senate two of our Bills -HB1177 and HB1190.

During this Legislative Session I was reminded of the words of Vern McLellan who wrote: "What the New Year brings to you will depend a great deal on what you bring to the New Year." It was my desire, as your SDRTL Lobbyist, that I would always bring to the Legislative Session a sense of truth, professional discernment, a gratitude attitude and most of all a Christ-like spirit.

We'll do our best to keep you informed on issues we identify as having potential impact on our South Dakota's Pro-Life Laws and yes, we are already in the planning stages for those Pro-Life Bills we may introduce in the 2020 Legislative Session.

Record Crowd Inspires at DC March for Life

I returned home with a renewed conviction of the importance of our South Dakota Right to Life mission to be a voice for the voiceless. We must continue to help change hearts and minds through education, legislation and prayer, so that one day all life will be respected and protected from conception to natural death.
