Planned Parenthood v. Noem (The Most Important Pro-Life Case in South Dakota's History)

In 2011 the South Dakota Legislature, and then Governor Dennis Daugaard, passed a **lifesaving law** (HB1217) requiring that pregnant women consult with a certified pregnancy help center, ensuring that they are protected from coercion and misinformation on abortion, before making such a life-altering decision.

However, that same year Planned Parenthood and the American Civil Liberties Union were able to obtain an injunction against this pro-life law.

For decades, the abortion industry has relied on deceptions, legal fallacies, and looking the other way when women are pushed into abortions. This billion-dollar industry cannot be trusted to look out for the interests of pregnant women.

Today this case, **Planned Parenthood v. Noem**, has been appealed to the United States 8th Circuit Court of Appeals. This is due, in large part, to the hard work and long hours invested by Leslee Unruh and the Alpha Center of Sioux Falls, along with their Attorney Harold Cassidy.

In defending this law South Dakota will have the full strength of our **Governor's Office**, the **SD Attorney General's Office** and the **ACLJ** (American Center for Law and Justice). Yes, the ACLJ's Chief Counsel Jay Sekulow and its legal team are representing the State of South Dakota and Governor Noem against Planned Parenthood.

We expect Planned Parenthood to respond to the filing soon, with oral arguments set for spring 2022. This flawed injunction, against our good pro-life law, must be **OVERTURNED**. Please join **SDRTL** in praying for the court's favorable ruling in this matter – all for the sake of **LIVES**.

South Dakota's brief and addendum on this case were recently sent to

the United States 8th Circuit Court of Appeals by the office of our SD Attorney's General Jason Ravnsborg. To read these two documents please go to www.sdRightToLife.org.

Will Roe Be Overturned?

The pro-life movement has been waiting for nearly 49 years, for the infamous Roe v. Wade decision to be overturned. On December 1, 2021 the US Supreme Court heard oral arguments on the Dobbs v. Jackson Women's Health case out of Mississippi which would ban most abortions past 15 weeks. Thousands of activists on both sides rallied outside while the Justices spent nearly 2 hours listening and questioning during the oral arguments of the case. It was a blessing to be able to join the crowds outside the Supreme Court, even if it was a couple hours after the official rallies were over. The sense of history was overwhelming. One side was filled with hope and prayers, while the other expressed anger and fear. After listening to the comments and questions from the Justices, most feel there is an excellent chance that Mississippi's law will be upheld. There is also very good reason to hope that the Court will go even further, possibly even overturning Roe and sending the issue back to the States. If Roe is not completely overturned, then South Dakota's case in the 8th Circuit Court (see page 1) would be another opportunity to overturn Roe.

When Roe is overturned and the authority to regulate abortions is returned to the States, South Dakota's Trigger Law will go into effect banning abortions in the State except when necessary to save the life of the mother. Now more than ever, we must rally around our pregnancy help centers to assure they have the necessary resources to help every mother experiencing a crisis pregnancy. We must also continue educating our families, neighbors and friends about the importance of protecting mothers and babies from the evil effects of abortion and be prepared to defend our trigger law in the event that abortion activists try to repeal it with a ballot initiative.

While we wait for the Supreme Court to announce their decision on this historic case (probably not until the end of June), let us be in prayer that the Justices will have the wisdom and courage to do what is best for our country and that all of us in the pro-life movement will do our part to promote a culture where all human life is protected and respected from conception to natural death.

If you can plan some travel, mark your calendars for June 24-25, 2022. We are pleased to announce that the 2022 National Right to Life Convention will be hosted at the Atlanta Airport Marriott Hotel in Atlanta, GA. Information, registration, contest info, etc. is at NRLconvention.org.

Also, now is a great time to register to vote, and to make sure your family members are registered.

"One of the most important ways anyone can help save unborn babies is with their vote. The impact pro-life voters make in sending pro-life candidates to Congress is immeasurable. Research demonstrates that pro-life legislation saves lives, which pro-lifers celebrate and pro-abortionists loathe. Every life saved is priceless.

If you've not voted previously, you do have to register. That only makes sense. But many, many people who have voted before have also moved. They may not know that if they have not updated their records, they will be ineligible to vote.

Let's start with basics. If you are 18 years old by Election Day, you are old enough to vote. The first

question is ... are you registered to vote?

You do not need to register again if you registered to vote for a prior election and still live at the same address. However, if you have never voted before, or have not voted while living at your current address, you will need to register.

Imagine getting all excited on Election Day about voting for the first time, or for the first time in a new address, only to find that—through some simple oversight—you're not properly registered. It's too late! Your unhappiness will be compounded by the knowledge that pro-abortion forces are out there working hard to register their own people."

Proclamation

WHEREAS, 2021 marks the 50th year since South Dakota Right to Life has been holding their Annual State Convention in the celebration of the Sanctity of Human Life from conception to natural death;

WHEREAS, the Preamble of the Declaration of Independence states that "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty, and the pursuit of happiness. That to secure these rights, governments are instituted among men . . .";

WHEREAS, as citizens of the United States, we recognize that without life, there is no Liberty. Without Liberty, there is no freedom in which the individual may pursue happiness. So, our policy must always be to defend human life at all stages;

WHEREAS, we must stand firmly united as a community that shows respect and love for the dignity and worth of every person, at every stage of life—the unborn, the aged, the disabled, the mentally ill—all of our most vulnerable neighbors;

WHEREAS, I respectfully encourage all South Dakotans to care for women with unexpected or unwanted pregnancies, to encourage responsible fatherhood, to affirm our state's pro-life pregnancy centers, to support adoption and foster care, and to ensure that every child can be raised to live and to have the liberty to pursue their own happiness;

NOW, THEREFORE, I, Paul TenHaken, Mayor of the City of Sioux Falls, do hereby proclaim October 1-2, 2021, as:

A CELEBRATION OF LIFE WEEKEND

in Sioux Falls. I ask every citizen of this great city to join me in considering what we have missed by the loss of lives who have been cut short and then to raise our voices in defending and cherishing human life. 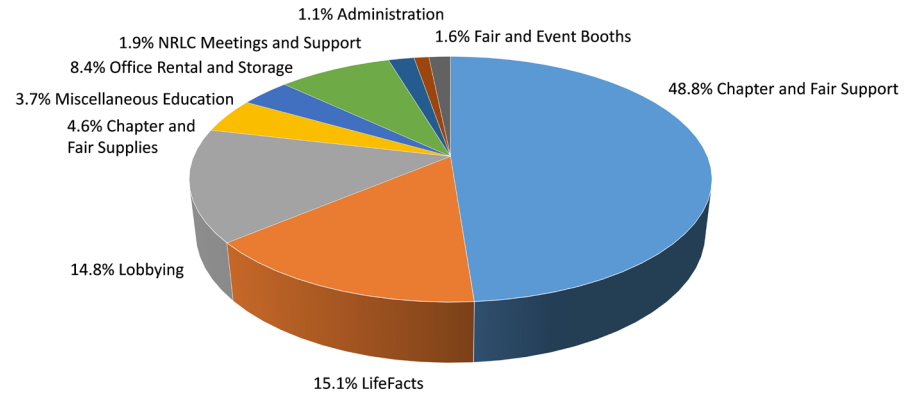
As 2021 comes to a close, let us take a look at how South Dakota Right to Life has worked to ensure that the most is made of every contribution that we have received and hope that you will partner or continue to partner with us as a sustaining member in 2022.

We have completed our ‘2020 FINANCIAL REVIEW’ through an accredited accountant and are pleased to share with you that no material modifications of our financial statements or procedures were necessitated by the complete review of our 2020 financial documents and accounting procedures. This conclusion only confirms the fact that SDRTL is committed to ensuring that your contribution is devoted 100% to PRO-LIFE and is not diminished by organizational inefficiencies or waste.

In 2021, roughly 49% of your donations have gone toward providing staff in support of chapters, pro-life outreach, and coordinating booths and exhibits at fairs and other events. Lobbying for pro-life legislation each session in Pierre has taken up another 14.8% of our budget. The LifeFacts that you receive goes to 17,000 households and makes up more than 15% of this year’s budget. A remaining 4% of donations are spent on miscellaneous education outreach. Only 1.1% of your donation is being spent on administration expenses.
